

## 2009 Just Tomatoes Recipe Contest

### Eligibility

The Just Tomatoes Recipe Contest is open to adults 18 years or older who are residents of the United States. Professionals such as chefs, caterers, food editors, home economists or educators, or anyone who is involved in the professional preparation of food or recipes for pay, employees of the Just Tomatoes Company and their families are not eligible. Questions about eligibility requirements will be decided by the Just Tomatoes Company and all decisions are final.

### To Enter

#### 2009 Recipe Category: Appetizers and Small Plates

1. Send your original recipe that uses one or more of Just Tomatoes fruits or veggies in the following category: **Appetizers and Small Plates**

Your recipe can be an **Appetizer**, hot or cold, meatless or not .... Be creative! It can be a nibble, cocktail snack, or part of a "small plate" group. **Small plates** are mini-dishes that make a meal and are shared by more than one person. The recipe(s) **must include a least a cup of one or more of the Just Tomatoes, etc.! dried veggies or fruits.**

Recipes, along with contestant's name, complete address, phone number and age must be clearly typed or printed on 8-1/2 x 11-inch paper, one side only. Include email address and fax number, if applicable. Each recipe must be submitted on a separate sheet or entered electronically on separate forms.

2. Entry must include: recipe category, name of recipe, number of servings, list of ingredients with specific quantities in standard U.S. measurements in order of use, and complete preparation directions including baking/cooking time and temperature.
3. Recipe must include **at least one cup** of Just Tomatoes fruits or veggies. **If using more than one product, can be combined to equal one cup.**
4. Just Tomatoes products used as garnishes will not be counted in total amount used in recipe. Must include minimum quantities in actual recipes.

Beginning January 15, 2009, submit an original recipe online at [www.justtomatoes.com](http://www.justtomatoes.com), Or, mail to: 2009 Just Tomatoes Recipe Contest, PO Box 807, Westley, CA 95387. Contest ends April 15, 2009. There is no limit to the number of recipes submitted, but there can be only one winner per household. Entries sent via the U.S. mail must be postmarked no later than April 15, 2009. Entries sent via the Just Tomatoes website must be received by 11:59 pm (PST) on April 15, 2009. The Just Tomatoes Company is not responsible for entries that are lost or mishandled.

### Rules

- Recipe must be original. Recipes must not have been previously published in the same or nearly the same form. By submitting a recipe(s), you affirm that to the best of your knowledge, it is your original work and unpublished or it is an existing recipe that features four or more significant changes. Contestants are solely responsible for complying with any applicable copyright restrictions, and the Just Tomatoes Company assumes no obligations in that regard. By participating, each entrant accepts these rules and agrees to be bound by the decisions of the judges, which will be final.

- Participants and winners understand and agree that recipe entries (including photographs, if any) become the exclusive property of the Just Tomatoes Company upon submission and cannot be returned. All intellectual property rights in recipes and photographs submitted by participants are transferred to the Just Tomatoes Company upon submission and shall be owned thereafter by Just Tomatoes. Participants and winners further agree that entries may be used, edited, modified or expanded upon by Just Tomatoes or other contest sponsors in any way those organizations deem appropriate, without compensation to participants/winners.
- Winners grant permission to the Just Tomatoes Company for use of their name, photograph and/or likeness, for publicity or advertising purposes and similar promotions, and for winner's list, without compensation.
- Recipes not meeting all requirements will be disqualified.
- Void where prohibited or restricted by law. All federal, state and local laws apply.
- Winners will be solely responsible for any personal tax liability on the prize awards.

## **Judging**

- Recipes will be judged on taste, originality, appearance and ease of preparation.
- Winning recipes will be selected by a panel of food professionals. All decisions are final.
- The judging panel will disqualify any recipes known to have been previously published or previous recipe contest winners.
- Judges will select **A TOTAL OF TWO** Grand Prize winners, and **TWO** second and **TWO** third place winning recipes. Each Grand Prize award is \$500 and 2 products a month for a year; second prize is \$50 and 24 products within 12 months following the contest; third prize is \$25 and one time shipment of 6 products.
- Winners will be selected on or about the week of June 1, 2009 and be notified by telephone or email. Letter of verification will follow within 14 days. Winners will be required to execute an affidavit of eligibility and release form which must be returned within 10 days of receipt of the form, or they will be disqualified and an alternate winner selected.
